

## Minnesota's Stay Safe Plan – Dialing Back – November 18, 2020

<b>Social Settings</b>	<b>Changes begin November 20 at 11:59 p.m.</b> <b>Do not gather with people from other households.</b> No indoor or outdoor gatherings, except with immediate household members. No person from outside your immediate household should enter your home.
<b>Critical Businesses</b>	Open (must telework if you can, must have a COVID-19 preparedness plan by June 29, 2020)
<b>Non-critical Businesses (non-customer facing)</b>	Open (must telework if you can, must have COVID-19 preparedness plan)
<b>Retail</b>	Open (must have COVID-19 preparedness plan)
<b>Restaurants and Bars</b>	<b>Changes begin November 20 at 11:59 p.m.</b> <b>Closed to public.</b> Except for delivery and takeout. Up to five customers at a time may be inside the establishment to pick up orders.
<b>Personal services (salons, tattoos, barbershops)</b>	<b>Capacity:</b> 6 feet of distance, max 50% -- see guidance for additional details <b>Appointments:</b> Required
<b>Gyms, personal fitness and yoga studios, martial arts</b>	<b>Changes begin November 20 at 11:59 p.m.</b> <b>Closed to public.</b>
<b>Indoor events and entertainment</b>	<b>Changes begin November 20 at 11:59 p.m.</b> <b>Closed to public.</b>
<b>Outdoor events and entertainment</b>	<b>Changes begin November 20 at 11:59 p.m.</b> <b>Closed to public.</b>
<b>School Buildings</b>	All public and private schools will follow the <a href="#">Safe Learning Plan</a> .
<b>Child Care</b>	Open per <a href="#">CDC guidance</a>
<b>Youth Programming</b>	Open per <a href="#">MDH guidance</a> and <a href="#">CDC guidance</a> Youth programs will continue to operate as long as the primary purpose is child care, not sports instruction or competition.
<b>Organized Sports (Adult and Youth)</b>	<b>Changes begin November 20 at 11:59 p.m.</b> <b>Closed.</b>

<b>Outdoor Recreation Activities and Facilities</b>	<b>Changes begin November 20 at 11:59 p.m.</b> Open per DNR's <a href="#">Outdoor Recreation Guidelines</a> All indoor facilities at outdoor recreation sites will be closed. <b>Gathering outdoors is allowed with immediate household members ONLY.</b>
<b>Places of Worship, religious services, weddings, and funerals</b>	<b>Changes begin November 20 at 11:59 p.m.</b> <a href="#">Open with guidance.</a> <b>Strong recommendation for virtual services ONLY.</b> Weddings, funerals, and other similar planned ceremonies can be held with the current rules in place, but all receptions and gatherings connected to these ceremonies must be canceled or postponed.
<b>Reception spaces for celebrations or private parties</b>	<b>Changes begin November 20 at 11:59 p.m.</b> <b>Closed</b>
<b>Campgrounds and charter boats</b>	<b>Changes begin November 20 at 11:59 p.m.</b> Open with guidance <b>Gathering is allowed with immediate household members ONLY.</b>
<b>Large public gatherings over 250 people</b>	<b>Closed.</b>
<b>Pools and swim parks</b>	<b>Changes begin November 20 at 11:59 p.m.</b> <b>Closed.</b>
